

New research priorities for the Society have been defined. A new MSTs Outstanding Mentor Award is being launched. Further details on all of these initiatives are in the Research Committee report.

Dr. Carol Morris and the Education Committee have completed the MSTs/American Academy of Orthopaedic Surgeons (AAOS) Pathology Course. All course material is now with the AAOS for programming and should be rolling out shortly. The Evidence Based Medicine Committee, under the leadership of Dr. Ben Miller, remains very active. The committee is currently creating a Clinical Practice Guideline (CPG) on "The Use of Imaging Prior to Referral to a Musculoskeletal Oncologist" and an Appropriate Use Criteria (AUC) on "Surveillance of Local Recurrence and Distant Metastasis after Surgical Treatment of Bone and Soft Tissue Sarcoma." They have published our first informational statement. They are working diligently to identify possible registry options for the Society. Dr. John Heiner and the Practice Management Committee continue to protect and advance our interests in the billing/coding world. New allograft codes have been approved by the American Medical Association Relative Value Scale Update Committee (RUC). Dr. Joel Sorger and the Fellowship Committee continue to advance issues of importance to our fellowship programs. They are currently working with the Accreditation Council for Graduate Medical Education (ACGME) to update fellowship requirements.

Recall that the Executive Committee, during Dr. Kristy Weber's term as President, initiated a strategic planning process in 2013 which resulted in the *MSTs Strategic Plan 2014 – 2017* as well as new vision and mission statements. Now that 2017 is upon us, we will be creating a new 3-year strategic plan in the year to come. The process will begin with a new member survey which will be coming your way in the near future. So, please stay tuned and participate in the process. We need your input!

Finally, our Annual Meeting in Denver is coming up quickly. We have an exciting venue planned and we look forward to seeing you all there! As you can see in this newsletter, there is currently a lot of

energy in the Society, from members of all age groups and practice types. We welcome your continued participation and feedback.

Evidence Based Medicine Committee

- Ben Miller, MD, Chair

The Evidence Based Medicine (EBM) Committee is continuing to work on two projects jointly funded by the AAOS and MSTS. The first is a clinical practice guideline "The Use of Imaging Prior to Referral to a Musculoskeletal Oncologist." For the next several months, we will be working on formulating the guidelines in preparation for approval and dissemination. Second, Dr. Rajiv Rajani is the primary investigator on an appropriate use criteria "Surveillance of Local Recurrence and Distant Metastasis after Surgical Treatment of Bone and Soft Tissue Sarcoma," which is in the middle of an initial stage of conference calls with a working group of radiologists and MSTS members.

Dr. Felasfa Wodajo has completed our [first Informational Statement](#), "Inappropriate Excision of Unrecognized Soft Tissue Sarcoma." We thank all of the MSTS members who took the time to comment on the document, which has since been adopted by the MSTS Executive Committee and is available on the [MSTS website](#). Please help us put the word out by telling colleagues inside and out of orthopaedics about these recommendations so we can get the information into the hands of clinicians (e.g. general surgeons, primary care physicians) that may help us avoid inappropriate excisions and optimize timely referrals. Future topics include the evaluation of a destructive lesion of bone of unknown etiology and the treatment of metastatic disease of bone. We are always looking for new ideas, so please let us know if you have an idea for a topic in need of an information statement.

The effort to create an MSTS registry had some good news as we were awarded the OREF/MSTS grant to proceed with initial infrastructure building and a 12-center pilot study. All of us are very thankful to our members who contribute to the OREF, and in particular Dr. Carol Morris, whose contribution to the grant mechanism was specifically noted. Currently we are in discussions with the AAOS to determine if our vision will be able to be incorporated into a larger effort, recognizing that the

priority is a research-quality database that contains the functionality and data elements most important to our members and patients. The working group has been re-engaged to determine the details of our scientific goals and the administration of the platform.

MSTS Practice Management Committee

The allograft codes were approved in the spring at the American Medical Association Relative Value Scale Update Committee (RUC) meeting. Thank you to the MSTS membership for filling out enough surveys to get the codes valued. The three codes will have a final value approved by Centers for Medicare and Medicaid Services (CMS) this fall so hopefully CMS will not decrease the values from the approved values at the RUC. These are surgical add-on codes.

The three codes are:

1. Osteoarticular graft with fixation
2. Hemicylindrical cortical graft with fixation (i.e. parosteal osteosarcoma)
3. Cylindrical cortical graft with fixation (i.e. diaphyseal osteosarcoma)

Resection of the tumor and other codes can be billed separately.

The open biopsy codes became zero day global codes this year, so remember any follow-up visits should be billed separately. The AAOS and other societies are currently battling with CMS over the use of the 25 modifier. This modifier enables physicians to bill for separately documented and distinct services on the same day. This is a problem if you see a patient and bill an E and M along with an injection code on the same day. Needless to say this happens all the time. CMS and its subsidiaries does not want to pay the E and M even if it is well documented. This would also effect any other zero day global or minor procedure code (such as the biopsy codes). The AAOS has taken the position that this is interference in patient care and, if the documentation supports the services delivered, that both codes should be paid. Fellowship Committee

The AAOS has approved the findings and recommendations of the Fellowship Accreditation Task Force (FATF). This task force was created by the AAOS to address the continuing frustrations with the ACGME accreditation process and their mandates. What this means and how it will be implemented is still being debated. We continue to work with the Residency Review Committee (RRC) to help refine the requirements for ACGME accreditation of Orthopaedic Oncology Fellowships. subspecialties.

NEWS FOR ONGOING MSTs/OREF FUNDED STUDIES

PARITY

The Prophylactic Antibiotic Regimens in Tumor Surgery (PARITY) trial now has 45 open sites across 9 countries and 6 continents. Enrollment reached 254 patients in the spring of 2017 and the study is expected to reach the 50% mark of the 600 patient enrolment target this year! The trial is ongoing and the collaborative network welcomes further expansion. Transcutaneous Oximetry as a Predictor of Wound Healing Complications in Preoperatively Radiated Soft Tissue Sarcoma (PI: Dr. Lukas Nystrom)

This prospective study is nearly one year into the MSTs/OREF funding cycle (7/1/2016-6/30/2018). The grant is being transferred to Cleveland Clinic as Dr. Nystrom is changing institutions. There are 2 sites actively enrolling patients (Loyola and Iowa) with 5 sites prepared to enrol (Cleveland, Medical University of South Carolina, Oklahoma University, UTHSCSA and University of Florida) once the institutional transfer is complete. Ten patients have been enrolled (25% of 2-year target). Great job Luke and team!!!

NEW INITIATIVE AIMED AT IDENTIFYING RESEARCH PRIORITIES IN ORTHOPAEDIC ONCOLOGY

The MSTs, in collaboration with the OREF, is pleased to report the completion of the project, entitled *'Moving forward through consensus: A protocol for a modified Delphi approach to determine the top research priorities in the field of orthopaedic oncology.'* This project involved a 3-stage process: 2 email questionnaires followed by an in-person consensus panel held at the MSTs Annual Meeting in Detroit, in October 2016.

This study was funded by an Innovation Grant (McMaster Surgical Associates) and the study protocol is published in the *British Medical Journal (Open)*: *BMJ Open* 2016;6:e011780. doi:10.1136. The final report has been submitted to *Clinical Orthopaedics and Related Research* for publication. A total of 80 participants from 16 countries contributed to the MSTs consensus project.

The top four research priority questions identified in this process are:

- (1) Does less-intensive surveillance of patients with sarcoma affect survival?
- (2) What are the survival outcomes over time for orthopaedic oncology implants?
- (3) Does resection versus stabilization improve oncologic and functional outcomes in oligometastatic bone disease?
- (4) What is the natural history of untreated fibromatosis?

Work is underway by MSTs members and international collaborators to answer these important research priorities! Stay tuned!

4. **Submission deadline:** July 31st 2017




